IN ADDITION, THE COMPENSATION COMMITTEE WILL APPROVE THE SPECIFIC SALARIES OF ALL EMPLOYEES AS RECOMMENDED BY THE EXECUTIVE COMMITTEE. THE AMOUNT OF THE BUDGET AND THE AMOUNT OF THE CEO'S COMPENSATION WILL BE BASED ON A REVIEW OF COMPENSATION FOR SIMILAR POSITIONS AT SIMILAR ORGANIZATIONS USING THE BI-ANNUAL MINNESOTA NONPROFIT SALARY AND BENEFITS SURVEY.

3. THE COMPENSATION COMMITTEE WILL RECOMMEND APPROVAL OF THE PROPOSED COMPENSATION BUDGET, INCLUDING THE CEO'S COMPENSATION, TO THE EXECUTIVE COMMITTEE. THE RECOMMENDED BUDGET WILL INCLUDE SALARY RECOMMENDATIONS FOR ALL PAID POSITIONS WITHIN VEAP.

4. THE EXECUTIVE COMMITTEE WILL REVIEW AND RECOMMEND APPROVAL BY THE BOARD OF DIRECTORS OF THE COMPENSATION BUDGET FOR THE UPCOMING YEAR, AND WILL PROVIDE THE BOARD WITH A SUMMARY OF THE PAYROLL AND SALARY PACKAGE.

5. THE COMPENSATION BUDGET WILL BE APPROVED BY THE BOARD.
